eight. In addition the center offers educational experiences geared towards adults. The Green Center hosts a quarterly speaker
series inviting various professionals to discuss how they connect to nature. The educational staff provides hands-on professional
development seminars in ecology, inquiry based methodologies and arts integration for local teachers and informal educators.
